Information regarding Colorado House Bill 13-1216

This bill is in regards to renewable energy. It has wording regarding tower structures. The bill is aimed at temporary structures uses for meteorological testing to determine where wind energy farms may be located. Within the bill is wording regarding any tower 50' or higher needing to be marked with orange and white paint. Amateur community is trying to get exclusions in this bill for ham towers.

A potential threat to 5Ghz band is being monitored by the ARRL

Program about Clubs becoming Tax Exempt - Wayne Heinen NOPOH

Wayne Heinen gave a program about clubs applying for non-profit status. There was a great deal of good information in his presentation. The presentation will in a Power Point file that will be made available on the CCARC web page in the near future. Wayne pointed out that the RMHam group has a great deal of information on 501(c)(3) application and procedures on their web pages. The presentation will be put on the CCARC website as soon as possible.

Old Business - Doug Sharp K2AD

The motion to amend the By-Laws to allow the chairman and frequency coordinator to delegate and distribute the workload was brought to the group from the Fall 2013 meeting. The amendments were approved unanimously.

Short discussion regarding the continued work on finding ways to allow electronic meetings to be held, giving those with long travel distances better ability to attend meetings. This is still being studied by the Executive Committee.

Short discussion regarding allowing individual repeater trustees who are members of CCARC to be given votes. Currently these CCARC member trustees can only vote on matters regarding frequency coordination. There are currently 34 clubs who are CCARC members. There are over 400 coordination records, so it is obvious that individual trustees outnumber clubs. This is still being studied by the Executive Committee.

New Business - Doug Sharp K2AD

Proposed Changes in Frequency Coordination policies:

Doug discussed adoption of policies for narrowband repeaters to allow for better adjacent channel spacing and co-channel spacing. The policies would reduce to 100 miles from 125 miles for 1000'-2000' HAAT and reduce to 125 miles for greater than 2000' HAAT. These changes were unanimously approved. Doug will document and review with the Executive Committee these changes, which will then be posted to the CCARC web pages.

ARRL Repeater Directory issues:

Doug Sharp reported that the coordination information was submitted to the ARRL on time this year. In late November, the ARRL informed CCARC that they would no longer accept bulk format submissions to the ARRL directory. In addition, the ARRL did not pay CCARC the \$1 per record that they have always done in years past.

There were numerous communications between CCARC officers and ARRL officials regarding this issue and the end result was the ARRL stating that under no circumstances would the ARRL allow bulk format data to continue to be submitted. The typical income from these records has always been approximately \$400. The only way to update the information at present is for each record to be edited

manually on the ARRL website by the coordinator or by the repeater trustees themselves. There is no way for CCARC to update this information automatically with the ARRL and adds an onerous amount of work to an already challenging volunteer job. Other coordinators do not know how they will handle this extra workload. It was noted that the CCARC will be contacting the ARRL to inform them that the CCARC would not be donating to the ARRL legal defense fund this year due to their non-payment for our repeater directory submissions. Doug noted that the CCARC will be providing the bulk data submisstion to RepeaterBook.Com and that member clubs should be encouraged to utilize this resource.

2014 Colorado QSO Party

A motion was made for CCARC to again sponsor 10 placques for the Colorado QSO Party. These placques are \$40 each. The motion was approved unanimously.

CCARC Internet Web Hosting

A motion to compensate John Maxwell for the many years he has provided free Web Hosting of the CCARC pages was made. It was passed unanimously to compensate John \$300 for the use of his web servers. John currently provides web hosting to over 50 non-profit organizations.

Next Meeting - Doug Sharp K2AD

The next meeting will be held either October 11, 18, or 25. ARRL Rocky Mountain Division Director Brian Mileshosky N5ZGT has asked to attend, so Doug requested that this meeting be held somewhere in the vicinity of DIA, to allow Brian to fly in and not have to drive far. RMHam agreed to host this meeting.

In lieu of a special presentation at the next meeting, Doug suggested that there be a round table discussion regarding what clubs are doing. Are clubs thriving or struggling? What works for your club and what doesn't work for a club.

The meeting was adjourned at 4pm.
